b. Parent Engagement Report - Ashley Wilford-Matthews

- Coffee talks were hosted monthly online and were well attended
- Virtual Kindergarten Meet & Learn in October, to help new Westmount parents feel more connected to the school and each other
- In December, we had an excellent presentation from Siksika Knowledge Keeper Elder Adrian Wolfleg
- At the end of January, Jill Foreman a Westmount parent and occupational therapist, hosted a session to discuss mental health

- In March, Westmount Superintendent Joe Frank and Board Member Dr. Hoda Kilani presented on charter schools in Alberta.
- In May and June, we have arranged for a two-part anti-racism presentation by the Alberta Civil Liberties Research Centre from University of Calgary,
- We have also begun sharing our Zoom parent engagement sessions with other charter schools and the GATE Parents Association, and they have generously done the same. This is an excellent way for us all to share knowledge and resources among various groups

c. Fundraising Report - Kim Anthony

- In total there were three bottle drives, two in the fall and one this year. Thank you to Jill Foreman who coordinated the bottle drives and organized the volunteers
- Stampeder parking is back. There were seven parking sessions, which ~\$5,500. Labour day weekend was a record day
- Thank you for Laura Teterenko, who organized the WCS Family Cookbook. The book was released in December and brought in over \$2,000. Thank you to everyone that submitted a recipe
- Thank you to all students who submitted designs for the Westmount United Tshirts this year. Congratulations to Alexis T. from grade 2 whose design was used
- Thank you for all of the direct donations, which totaled ~\$13,000
- Held both a 50/50 raffle and a WestJet raffle in the Spring, which raised \$13,850 and \$14,500, respectively
- Some of the areas where funding was allocated are:
 - Parent education presentations throughout the year
 - COVID-related expenses
 - Enhancement of students' experience through field trips and opportunities with guest speakers
 - Increased busing costs
 - In-classroom support
- Has completed two terms as fundraising director. Has been great to work with everyone. Looking forward to supporting next fundraising director
